Application at the recommended rates will last approximately 4 to 6 weeks.

**GROUND COVER:** Broadcast at 24.4 kg per 1,000 m<sup>2</sup> (per 2.4 kg per 100 sq. m<sup>2</sup>)

**SHRUBS & EVERGREENS:** Sprinkle 125 ml evenly around dripline of plant and work into top 2.54 cm of soil.

**TREES:** Apply 227 g per 2.54 cm of trunk diameter. Distribute evenly under branches out to dripline.

**NOTE:** Liquid measuring cups are very close in estimating the weight of dry granular fertilizers. *Example:* A 237 ml (1 cup) measuring cup holds approximately 227 g (¼ kg) of dry granular fertilizer.
